HOMESTAY PARENT AGREEMENT

In consideration of Pope John's accepting the Homestay Parent(s) to host a foreign student, the Homestay Parent(s) agree with the following:

- 1. The Homestay Parent(s) and anyone over 18 in the household are required:
 - To attend "Protecting God's Children" workshop
 - Undergo Criminal History Background Check
 - Sign Pastoral Code of Conduct
- 2. The Homestay Parent(s) agree that the fee paid by the student is \$1,075.00 per full month or pro-rated at a per diem rate of \$35.00.
- 3. The Homestay Parent(s) confirm that all household members desire to host the foreign student.
- 4. The Homestay Parent(s) agree to provide students with their own room with a suitable desk for study purposes and necessary items such as linens, towels, etc.
- 5. The Homestay Parent(s) will provide a clean, orderly, pleasant and safe living environment for the student.
- 6. The Homestay Parent(s) will provide to the student three meals a day, seven days a week consisting of a variety of nutritional well-balanced foods. These meals should be taken with the family whenever possible.
- 7. The Homestay Parent(s) agrees to provide transportation for the student to/from extra-curricular activities and rides to/from the airport, or will arrange an alternate ride if needed.
- 8. The Homestay Parent(s) will allow Cultural Exchange Program representatives to perform home visits as needed.
- 9. The Homestay Parent(s) will involve the student in family activities and outings.
- 10. The Homestay Parent(s) will **NOT** require the student to maintain their house or yard, babysit children or cook their meals. With the exception of keeping their room and all other areas used, such as the kitchen and bathroom, clean and orderly.
- 11. The Homestay Parent(s) will **NOT** leave students unsupervised overnight.
- 12. The Homestay Parent(s) will **NOT** allow students <u>under 18 years of age</u> to take unsupervised out of town trips.
- 13. The Homestay Parent(s) shall discuss with the Homestay Supervisor any unresolved misunderstandings or conflicts between the Homestay Parent(s) and student.
- 14. The Homestay Parent(s) will promptly notify the Homestay Supervisor of any changes with regard to household members (boarders, renters, family members moving in or out, etc.).
- 15. The Homestay Parent(s) will notify the Homestay Supervisor if the student attempts to move from their home.
- 16. Household members **shall not** abuse alcohol or drugs.
- 17. Household members **shall not** make improper advances toward the student.
- 18. The Homestay Parent(s) must instruct the student on the course of action to take in the event of fire and other emergencies.
- 19. Household members understand that if they do not meet program standards at any time the student may, at the discretion of the Homestay Supervisor, be moved from their home, without notice or lieu payment. Also, students may request homestay changes at any time if issues cannot be worked out
